## **ORDER**

WHEREAS, the institution namely Mahe Co-operative College of Teacher Education, Near Govt. Press, Main Road, Mahe-673310 Pondicherry was granted recognition vide SRC (NCTE) order no. F.PN-N/SRO/NCTE/2005-06/1522 dt. 23.06.2005 for conducting Secondary course of one-year duration with an annual intake of 100 students.

- 2. AND WHEREAS, the matter was further considered by the SRC in its 167th meeting held on 17th -18th November 2008 and Committee decided to withdraw the recognition. Accordingly, Withdrawal Order was issued on 17.12.2008. Followed by corrigendum dt. 01.01.2009. Thereafter, the institution preferred an appeal u/s 18 of NCTE Act, 1993 and the Appellate Authority vide order No. F.No.89-115/2009-Appeal Appeal/dt. 21.06.2009 remands back the case the direction to SRC to get the institute inspected on submission on submission of requisite fee. The re-inspection of the institution was conducted on 27.07.2009, the VT report was considered by SRC in its 180th meeting held on 29.07.2009 and the committee decided that Continue Recognition. Accordingly, continue recognition order was issued to the institution on 11.08.2009.
- 3. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dt. 25.11.2017 consented to come under new Regulations.
- 4. AND WHEREAS, the Southern Regional Committee (NCTE) issued the Revised Provisional Recognition order dt.25.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.
- 5. AND WHEREAS, on being consideration of the representation dt. 12.01.2018 submitted by the institution, the change in unit size from 2 to 1 was permitted by the SRC in its 301st meeting. The Pondicherry University vide letter No. PU/AW-1/11/2016-17/195 dt. 14/20.12.2016 shows about affiliation and admission on 50 seats only for the academic year 2016-17. The SRC in its 349th meeting held on 15.12.2017

considered the request of the institution for maintaining 2 units of B.Ed. course and accepted the same. The SRC in its 349<sup>th</sup> meeting held on 15.12.2017 considered the request of the institution for maintaining 2 units of B.Ed. course and accepted the same.

- 6. AND WHEREAS, on being received a complaint dt. 03.06.2016 the SRC in its 367<sup>th</sup> meeting decided to obtain the comments / report of the affiliating body on the points mentioned in the complaint and in response the Pondicherry University vide letter No. PU-AW-1/11/2018-19/127 dt. 12.02.2019 submitted the comments. The institution has also submitted a letter dt. 01.10.2019 for enhancement of 10% quota for EWS as additional intake. The matters of adherence of compliance of the NCTE Regulations, 2014, enhancement of 10% quota for EWS and comments of University on compliant are placed before the SRC for consideration and decision
- 7. AND WHEREAS, the matter was further considered by the SRC in its 393<sup>rd</sup> meeting held on 05<sup>th</sup> -06<sup>th</sup> January 2021 and the Committee decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **Mahe Co-Operative College of Teacher Education, Pondicherry** for B.Ed programme for 1 basic unit of 50 students.

In the matter of complaint received against the institution, the committee decided to close the matter on the basis of report submitted by the Pondicherry University.

8. NOW THEREFORE, this order is issued permitting the institution continuation of conducting Mahe Co-operative College of Teacher Education, Near Govt. Press, Main Road, Mahe-673310(Survey No. 61/5) Pondicherry run by The Mahe Co-operative centre for information Technology Ltd. No. P.689 Cemetery Road, Manjakkal, Mahe-673310. Puducherry for B.Ed. course of two years duration with an intake of 50 students (one basic units) subject to fulfilment of the following conditions:



- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation form the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;



- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information, if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The Institution shall fill the information on GIS Portal on the NCTE Website. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
